

#### DON'T

- Modify Sweed brand assets in any way, such as by changing the design or color.
- Don't display the Sweed brand in a manner that is in Sweed's sole opinion misleading, unfair, defamatory, infringing, libelous, disparaging, obscene or otherwise objectionable to Sweed.
- Don't incorporate Sweed brand into your own product name, service names, trademarks, logos, or company names.
- Don't copy or imitate Sweed's trade dress, including the look and feel of Sweed web design properties or Sweed brand packaging, distinctive color combinations, typography, graphic designs, product icons, or imagery associated with Sweed.
- Don't adopt marks, logos, slogans, or designs that are confusingly similar to our brand features.
- Don't use or register Sweed trademarks as, or incorporated in, social media account names, profiles, or monikers.
- Don't register Sweed trademarks as second or third level domain names.
- Don't use Sweed trademarks in a way that suggests a common, descriptive, or generic meaning.
- Don't use Sweed Marks or the Sweed name in any spam, direct marketing communications or any unsolicited advertising, promotional materials or other forms of solicitation or commercial content.
